**HOUSEHOLD DEFENDANTS' MOTION  
FOR PARTIAL RECONSIDERATION AND CLARIFICATION  
OF THE COURT'S APRIL 27, 2007 ORDER**

Defendants Household International, Inc. and Household Finance Corp. and its former officers and directors William F. Aldinger, David A. Schoenholz, Gary Gilmer, and J.A. Vozar (collectively, "Defendants") hereby move this Court (i) to reconsider its April 27, 2007 Order insofar as it directed Defendants to produce and/or log all documents in Defendants' files regarding the privileged Compliance Engagement performed by Ernst & Young ("E&Y") during the period July 2002 through early 2004 and (ii) to clarify that its April 27, 2007 Order did not intend to overrule its prior directives with respect to the one seven-hour day duration of the depositions of Messrs. Keller and Bianucci of Ernst & Young. In support of this motion, Defendants submit the accompanying Memorandum of Law in Support of the Household Defendants' Motion for Partial Reconsideration and Clarification of the Court's April 27, 2007 Order, and the Declaration of Landis C. Best in further support thereof.
