**NOTICE OF ERRATA REGARDING PLAINTIFFS' [PROPOSED] FINAL JUDGMENT
PURSUANT TO FEDERAL RULE OF CIVIL PROCEDURE 54(b)**

PLEASE TAKE NOTICE that plaintiffs, by and through their attorneys, submit this Notice of Errata to correct an error in the [Proposed] Final Judgment Pursuant to Federal Rule of Civil Procedure 54(b) (“Final Judgment”) and an error in the Exhibit A thereto.

The Final Judgment, which was filed on October 9, 2013 (Dkt. No. 1889), incorrectly states that defendant Gary Gilmer is severally liable for 15% of the judgment. Defendant Gary Gilmer is in fact severally liable for 10% of the judgment. In addition, the amount of prejudgment interest to October 10, 2013 set forth in the Exhibit A to the Final Judgment is incorrect. The calculation was mistakenly from October 11, 2002 to July 31, 2013, instead of until October 10, 2013. The correct prejudgment interest amount to October 10, 2013 is \$984,215,925. Given that the Court has set a deadline of October 15, 2013 at noon for defendants to object to the Final Judgment, plaintiffs have revised the prejudgment interest in the attached Exhibit A to the Final Judgment with a calculation of prejudgment interest through October 15, 2013, which totals \$986,095,388.

In order to correct these errors, plaintiffs hereby submit a corrected Final Judgment and Exhibit A thereto.
