Lead Plaintiffs' and Lead Counsel's Motion for An Award of Attorneys' Fees and Expenses ("Fee and Expense Application") is currently set for hearing on March 19, 2015. Pursuant to ¶7 of the Court's November 18, 2013 Order (Dkt. 1912), Lead Plaintiff and Lead Counsel respectfully request that the Court adjourn the hearing until a date in June 2015 for the reasons set forth herein.

In November 2013, defendants appealed from the judgment, which was entered by this Court on October 17, 2013. The Seventh Circuit Court of Appeals held argument on the appeal on May 29, 2014. As of today's date, the Court of Appeals has not rendered its decision. Ultimately, the decision may impact the fee and expense application. If defendants prevail, the judgment may be vacated and the application could be rendered moot. If plaintiffs prevail, this Court should consider the final result achieved for the Judgment Class members in rendering its decision. Therefore, Lead Counsel ask the Court to continue the hearing until a date convenient for the Court in June 2015, by which time the Court of Appeals may have rendered a decision.

Defendants do not oppose the Motion.
