**PLAINTIFFS' MOTION TO WITHDRAW LEAD PLAINTIFFS' AND LEAD  
COUNSEL'S FEES AND EXPENSE APPLICATIONS AND TO ADJOURN THE  
RELATED JUNE 24, 2015 HEARING**

Lead Plaintiffs' and Lead Counsel's Motion for An Award of Attorneys' Fees and Expenses ("Fee and Expense Application") is currently set for hearing on June 24, 2015. Lead Plaintiff and Lead Counsel respectfully request that the Court adjourn the hearing for the reasons set forth herein.

In November 2013, defendants appealed from the judgment, which was entered by this Court on October 17, 2013. On May 21, 2015, the Seventh Circuit Court of Appeals issued its opinion remanding the case for a new trial on certain limited issues. Plaintiffs filed a petition for panel rehearing as to one issue in the opinion on June 4, 2015. As of today's date, the Court of Appeals has not rendered a decision with respect to the petition for rehearing. However, even if that petition is granted, the judgment will still be reversed and the case remanded to this Court for further proceedings. Therefore, Lead Counsel believes that the Fee and Expense Application is now moot. Lead Counsel ask to withdraw the motion, subject to re-filing if plaintiffs prevail at the new trial, and ask the Court to adjourn the hearing scheduled for June 24, 2015.


